- 11 Payment shall be made only after performing journey

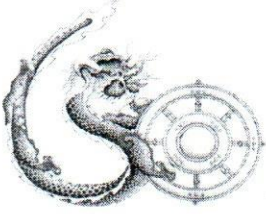
