5. The validity of issuance of ticket shall be not less than three days from date of opening tender.
6. Rate should quote for direct and shortest route.
7. **CONDITION FOR "SUBJECT TO AVAILABILITY OF SEAT"** will not be entertained.
8. Ticket should not contain any term & condition as it is a full fare ticket.
9. In case of connecting flights, more than 3 hours waiting time for the next flight should be maintained.
10. Decision of the Tender committee will be the final and binding.
11. The payment shall be released only after performing the journey.
