# **Royal Audit Authority signs Memorandum of Understanding** with National Audit Office of Finland



The Royal Audit Authority (RAA), in its endeavor to strengthen the professional capacity of the institution, had established bilateral relationship with peer Supreme Audit Institutions. So far, the RAA has Memorandum of Understanding (MoU) only with the SAIs from ASOSAI region. For the first time in the history of the RAA, the RAA signed MoU with the National Audit Office of the Finland from EUROSAI region. The MoU was signed on 22 July 2019 in New York to enhance the institutional capacities in the areas of auditing of Sustainable Development Goals (SDGs), environmental auditing and data analytics. It will also enable the two audit institutions to share information and experiences on auditing topics from time to time that may be considered important and beneficial for both the Parties. The MoU was signed during the sideline meeting between Auditor General of Bhutan, Dasho Tshering Kezang, and the Auditor General of Finland, Ms. Tytti Yli-Viikari, who were attending the SAI Leadership and Stakeholder meeting on "Supreme Audit Institutions making a difference: Auditing the implementation of the Sustainable Development Goals" in New York, USA.

#### Royal Audit Authority signs Memorandum of Understanding with State Audit Office of Republic of Vietnam



The Royal Audit Authority and the State Audit Office of Vietnam signed a Memorandum of Understanding (MoU) to strengthen, promote and develop cooperation between the two Supreme Audit Institutions. The MoU was also to strengthen respective institution's professional capacity and improve work methodologies specifically in the areas such as application of International Standards of Supreme Audit Institutions (ISSAIs), Environmental Auditing, IT Auditing and IT application into institutions' activities, capacity development programmes; and any other areas of cooperation of mutual concern agreed upon by the Parties.

The MoU was signed between the Auditor General of Bhutan, Dasho Tshering Kezang and the Auditor General of Vietnam, Ho Duc Phoc on 12 November, 2019 at the State Audit Office of Vietnam corresponding to the 15th day of ninth month of the Earth Pig year. On the invitation of the National Assembly of Vietnam, the Auditor General of Bhutan also met the Vice Chairman of the National Assembly of Vietnam and discussed on the possible areas of mutual benefits.

#### Hon'ble Auditor General attends the SAI Leadership and Stakeholder meeting in New York

The Auditor General, Dasho Tshering Kezang led a three-member delegation to attend the Supreme Institutions Audit (SAI) Leadership and Stakeholder meetina on "Supreme Audit Institutions making a difference: Auditing the implementation of the Sustainable Development Goals" in New York, USA from 22-23 July 2019. The meeting was jointly hosted by the United Nations Department of Social and Economic Affairs (UNDESA) and the INTOSAI Development Initiative (IDI).

The meeting provided a platform amongst SAIs to share and take stock of three years of experiences in conducting performance audits of government preparedness for the implementation of the Sustainable Development Goals (SDGs). The meeting also facilitated an informed dialogue between SAIs and stakeholders regarding the contribution of SAIs and external audits to the SDG review mechanism at different levels.

Hon'ble Auditor General visits State Audit Office of the Kingdom of Thailand



The Auditor General Dasho Tshering Kezang accompanied by Deputy Auditor General and HR officer visited the State Audit Office of the Kingdom of Thailand on 18 November, 2019. The purpose of the visit was to strengthen the collaboration and cooperation between the two SAIs on the mutual interest and to promote the INTOSAI Moto "mutual experience benefits all" based on the Memorandum of Understanding (MoU) signed in 2016. Further, the two SAIs shared experiences and discussed on other areas of common interest in public sector auditing.

During the delegation, His Excellency, the President and the Auditor General of SAO of the Kingdom of Thailand highlighted on further strengthening the collaboration between the two SAIs in the capacity development of human resource. Both SAIs shared experiences on the following areas:

- Human Resource Management
- Human Resource Development
- Performance Management System
- International Relations and Cooperation

Both SAIs also recognize a need to foster cooperation in Human Resource capacity development through exchange visits, academic conferences, auditing methodologies, ISSAIs implementation, joint and parallel audits in the areas of common interests.

# Hon'ble Auditor General meets the Comptroller General of Government Accountability Office, USA



Hon'ble Auditor General, while attending the SAI leadership and Stakeholder meeting in New York, visited the Government Accountability Office and met with the Comptroller General, Mr. Gene Dodaro in Washington D.C. on 26 July 2019. The meet was mainly organized to discuss on future possibility of collaboration between the two institutions in improving public accountability and good governance in public operations. During the meeting, the Auditor General conveyed appreciation to GAO in extending support for International Auditor Fellowship Pragram in GAO every year for two candidate from the RAA.

# RAA presents Annual Audit Report 2018 to PAC and other Members of Parliament



The Royal Audit Authority presented the Annual Audit Report 2018 to the Public Accounts Committee and other Members of Parliament on 24 July 2019. The presentation covered the contents of the AAR 2018 focusing on significant findings and key recommendations. The presentation was followed by questions and answers session. The AAR 2018 was submitted to His Majesty the Druk Gyalpo and tabled in the Parliament on 21 June 2019. The report will be reviewed by the PAC and presented to the Parliament for deliberation in the next Parliamentary Joint Sitting of the National Council and National Assembly.

#### RAA conducts its 16<sup>th</sup> Audit Conference at PDC, Tsirang



The RAA hosted its 16<sup>th</sup> Audit Conference after four years at the Professional Development Center, Tsirang from 8 to 12 July 2019 on the theme 'Value and Benefits of SAI: Making a difference in the lives of citizens'. The opening ceremony was graced by His Excellency the Hon'ble Speaker of the National Assembly, Tshogpon Wangchuk Namgyel as the Chief Guest and attended by the Hon'ble members of Public Accounts Committee, Dasho Dzongda, Dasho Drangpon, Superintendent of Police, and Lam Neten of Rabdey.

The synopsis of the theme paper was briefly presented to the floor by Tashi Tobgay, AAG during the opening ceremony. Besides, the Lam Neten administered the "Oath of Good Conduct, Ethics and Secrecy" to 36 new employees in presence of the Chief Guest, Auditor General, and other distinguished guests. The Chief Guest also awarded the promotion orders to 24 employees and AG's Compliance Assurance Award for three best Audit Reports during the FY 2016-17 and 2017-18 and best three Significant Audit Observations for 2016-17 and 2017-18.

The Hon'ble Auditor General presented the AG's Report to the 16th Audit Conference on the initiatives and accomplishments of RAA from July 2015 to June 2019. The Chief Guest launched the Financial Audit Manual, Performance Audit Guidelines, Environment Audit Guidelines, Followup Guidelines and Outsourcing Policy. The website of PDC, Tsirang was also launched by the Hon'ble Chief Guest.

During the four-day conference, there were presentations from Public Accounts Committee (PAC), Ministry of Finance (MoF), Gross National happiness Commission (GNHC), Certified Professional Accounts (CPA) Australia and Anticorruption Commission on various thematic and emerging issues. The house also reviewed status of RAA's Strategic plan 2015-2020, ISSAI based audit review, Common issues raised during audit sensitization program and challenges faced by the RAA. There were presentations on the stakeholder engagement strategy, Human resource retention strategy and competency framework of auditors.

#### **3<sup>rd</sup> Assistant Auditors General Meet at PDC, Tsirang**



The 3rd Assistant Auditors General's Meet was held from 5-6 July 2019 at Professional Development Centre, Tsirang. Joint Auditor General, two Deputy Auditors General, and Assistant Auditors General of Divisions from Head Office and Regional Offices attended the meeting. The meeting was held mainly to discuss and prepare the Annual Audit Schedule 2019-2020. Apart from review of past resolutions and Strategic Plan 2015-2020, the meeting deliberated on the audit thrust areas and area of concerns that need to be focused while conducting audit and also revisited on the Audit Universe and its priorities and categories.

The human resource gaps as well as human resource rationalization exercises were carried out and strategized on how audits can be managed with the available resources. Additionally, the meeting discussed and identified activities to be included in the Annual Audit Plan 2019-2020.

#### RAA participates in QA Review Panel Meeting

The INTOSAI Development Initiative (IDI) organized Quality Assurance (QA) Review Panel Meeting for training QA Reviewers on conducting QA Reviews for SAIs who participated in the Cooperative Performance Audits of preparedness for implementation of SDGs. The Quality Assurance review is the last stage of the IDI cooperative audit support model. The purpose of the QA is to verify if the audits were conducted in accordance with the ISSAIs.

Nine auditors from SAIs of Bhutan, Brazil, Georgia, Ghana, Indonesia, Jamaica, Philippines, Thailand and Uganda took part in the panel meeting held Auditor, Office of the Assistant Auditor General, Tsirang participated as QA reviewers.

The QA Meeting is a component under the INTOSAI Development Initiative (IDI) Global Programme on SAIs Fighting Corruption launched in 2015. A part of the programme, 61 Supreme Audit Institutions (SAIs) in the INTOSAI community have taken up cooperative

audits of Institutional Frameworks for Fighting Corruption and are either in the process of finalizing their audit reports or have already published their reports. Participants from 61 member SAIs participated in the IDI funded QA Meeting.

from 9-12 September 2019 in Manila, Philippines. The trained QA Reviewers will conduct QA Reviews for audit reports published by 12 SAIs as part of the Cooperative Performance Audits programme.

The RAA also participated in the roundtable meeting with Asian Development Bank's (ADB) Public Financial Management (PFM) Portfolio Manager to discuss

#### **ISSAI** based Financial and Performance Audit Training



International Standards of Supreme Audit (ISSAI) based Financial Institutions and Performance Audit Training was conducted from 15-17 July 2019 at Professional Development Centre, Tsirang. 116 financial auditors attended the financial audit training and 14 performance auditors attended the performance audit training. The training was delivered by ten and three inhouse ISSAIs facilitators and mentors for Financial Audit and performance audit respectively. The three-day financial audit training was mainly imparted in-depth knowledge on the applications of ISSAIs in financial auditing process that encompasses the pre-engagement activities,



planning and conducting an audit, completion and review, and reporting. It will also familiarize the participants on revised Financial Audit Manual of the RAA, which was published during 16th Audit Conference.

Likewise, the performance audit training covered General Principles and Standards of ISSAIs for Performance Auditina. lt also included development of Strategic Plan of Performance audits, planning individual performance audit, conducting, reporting and follow gu of performance audit. The training also discussed issues the teams had encountered while using the guideline in the field and came up with common understanding of applying the Performance Audit Guideline.

#### **Effective Follow-up Training**



Follow-up is a main tool of the RAA to ensure that audit issues are timely and sufficiently addressed by the audited agencies and accountable officials. It also enables the RAA to keep track of all unresolved audit issues and provide Audit Clearance service to the general public. As such, a three-day training on "Effective Follow-up of Reports" was held at Professional Development Centre, Tsirang facilitated by three experienced senior officials of the RAA from 29-31 July 2019. During the training, participants were familiarized on the newly developed Follow-up Guidelines of the RAA which was launched on 8 July 2019. The training imparted hands-on sessions on follow-up of Annual Audit Report with practical case studies. The training course also included the method of interest calculation on the audit recoveries, record keeping of the audit recoveries that are not credited into Audit Recovery Accounts, Audit Information Management System (AIMS) and eZotine. At the end of the training, the participants developed SOPs and Annual Plan for the Follow-up Division of RAA head office and the Follow-up Sections of four Regional Offices.

# Training on Interpretation and Analysis of Financial Statements



A five-day capacity development training on Interpretation and Analysis of Financial Statements was conducted from 26-30 August 2019 at Professional Development Centre – Tsirang. The opening ceremony for the training was graced by Hon'ble Chief Guest, Chairman of the Public Accounts Committee in presence of Deputy Auditor General, Dept. of Follow-up, Region and HRM and Assistant Auditor General, Office of the Asst. Auditor General – Tsirang/Offtg. Program Director.

Three resource persons Jigme Dema, Senior Audit Officer and Nima, Audit Officer headed by Karma Jambayyang, Assistant Auditor General. Corporation and Financial Institutions Division deleivered the training to 40 team leaders of the Royal Audit Authority. The training aimed at making the participants have clear understanding of all the elements and contents of financial statements of Government, corporation and other agencies so as to minimize audit detection risks which in turn will reduce risk of expressing erroneous audit opinion on the audit financial statements.

#### **Construction Audit training**



Capacity development training on Construction Audits was held from 9-13 September 2019 at the Professional Development Centre, Tsirang. Hon'ble Dasho Auditor General graced the opening ceremony using Google Hangouts and reminded the participants on the importance of construction audit and urged to make best use of the opportunities and resources made available. The training was attended by 40 participants including three officials from Anti-Corruption Commission and intended to provide better understanding fundamentals on the of construction audit and the methods and techniques of construction audit. It is also expected to equip auditors with adequate knowledge and skills towards enhancing professionalism.

# **IT Audit Training**



Recognizing the role of Information Technology in a fast changing world, a three-day capacity development training on IT Audit for 26 auditors was provided from 28-31 October 2019 at the Professional Development Centre, Tsirang. The training is part of annual capacity development programme 2019-2020.

The Program Director graced the opening of the training and reminded the participants to make best use of the resource persons to take away adequate knowledge and skills to enhance professionalism. The training aimed at making the participants understand the concepts of IT auditing, role of information technology and its controls in generating reliable reports, and understand the processes involved in IT audit. Imparting knowledge on these areas is expected to increase the coverage in IT audit which would enable RAA to make timely recommendations on IT controls of different agencies.

### **Data Analytics Trainings**



The paper based record keeping are being replaced by uses of wide range of IT tools and technology in their business processes and everything is connected and every single communication of information is recorded as 'data'. In the process, it generates massive volumes of data, commonly known as Big Data. Hence, Auditors need to be aware of such developments as far as the availability of information is concerned. The recent initiative of Ministry of Finance to introduce e-Payment System is another paradigm shift in the country.

As such, a three-day capacity development training on Data Analytics was held at PDC,

Tsirang from 4-8 November 2019. The main objective of conducting such a training was to build adequate knowledge and skills on fundamentals of data analytics which has gain paramount importance in a rapidly changing and data driven environment.

During the three days, the training covered the fundamentals of data

analytics in line with ISSAIs of Analytical Procedure and key features of IDEA software and MS-Excel. After availing the training, the participants were expected to perform analytical procedure using IDEA software and MS-EXCEL to the extent that it is in compliant to ISSAI 1520. The Program Director graced the opening of the training and reminded the participants to make best use of available resources to get equipped with software and application. He emphasized that the participants must remain inquisitive and keep exploring and using the tools on a day-today basis.
