



#### 1. INTRODUCTION

The RAA's annual operational plans are drawn from the Implementation Matrix of the Strategic Plan (SP) 2020-2025. The Operational Plan (OP) 2022-2023 is the third annual plan of the five-year strategic plan. It consists of host of prioritized activities linked to the results framework of SP, with detailed timeline and responsibility delegations for implementation. Implementation of the OP is expected to contribute to achievement of strategic intents.

The OP is aligned to other important strategies such as Human Resource (HR) Strategy, Annual Audit Schedule (AAS) 2022-2023, Annual Work Plan (AWP), and integrated with Information Technology (IT) Strategy, Organizational Integrity Plan (OIP) 2020-2023 and Stakeholder Engagement Strategy (SES) 2018-2023.

#### **Table 1: Results Framework**



A total of around 40 major activities will be implemented under ten outputs. The detailed plan is OP2022-2023 Activities Matrix as Annexure I and AAS 2022-2023 as Annexure II.

The plan will be implemented with a total approved budget of Nu. 200.134 million comprising Nu. 137.833 million for Mandatory Expenses, Nu. 32.740 million for Controllable Expenses and Nu 29.561 million for Capital Budget. A total of 270 employees of the organization, with 149 field and 121 non-field staffs will be involved to successfully implement the plan.

## 2. IMPLEMENTATION AND REPORTING

The OP 2022-2023 will be translated to Annual Performance Agreements/Commitments of individuals, team leaders, division chiefs and department heads in line with the responsibilities delegated for implementation of the plan. The Annual Performance Agreements/Commitments will be monitored and reported on a regular basis in Audit Information Management System (AIMS) and MaX system of the RCSC.

#### 2.1 Monitoring Plan

The Policy and Planning Division (PPD) will coordinate and lead overall monitoring of the plan and conduct quarterly, half yearly and annual reviews during the Quarterly Plan Meetings, Mid-Term Review meeting and Year End Planning and Coordination Meet.

#### 2.2 Reporting Plan

The division chiefs, team leaders of task forces and committees, and PPD shall report on the progress and status of the plan. The report schedule is as below:
