14. Terms of Engagement

Engagement Process

- I. **Review of Financial Statements:**
The draft financial statements of the client are reviewed by the audit team. Discussions are held to assess the statements and estimate the audit fee.
- II. **Proposal Development:**
A financial proposal is prepared and sent to the client detailing the estimated audit fee.
- III. **Engagement Agreement:**
Once the financial proposal is accepted, RFPL sends an engagement letter for the client to sign, formalizing the audit arrangement.
- IV. **Audit Planning & Pre-Engagement Activities:**
The team lead initiates audit planning, distributes auditor independence questionnaires to team members for signing, and organizes an audit entry meeting to set the timeline and expectations for the audit.
- V. **Work Distribution & Sampling:**
The team lead assigns specific tasks related to substantive testing. Team members complete their respective sample selections and share them with the lead, who consolidates the data and forwards it to the client's focal person.
- VI. **Audit Field Work:**
Fieldwork begins, during which the team lead communicates key audit planning elements, including performance measures and materiality thresholds for transactions, to the team.
- VII. **Tracking & Summarizing Differences:**
Each team member updates the Summary of Unadjusted Differences (SUD) on a shared file in Google Drive. The team lead follows up on the status of the work and ensures progress is maintained.
- VIII. **Preliminary Discussion of Findings:**
Any audit observations are initially discussed with the finance team and client focal person to ensure alignment before finalizing the observations.
- IX. **Management Discussion:**
A formal meeting is held with management to discuss the audit findings and address any remaining issues.

- X. **Draft Audit Report & RAA Review:**
After finalizing the financial statements and receiving management's responses to audit observations, a draft audit report is prepared and submitted to the Royal Audit Authority (RAA) for their reference.
- XI. **Exit Meeting:**
Audit Observation and feedback from RAA and management is discussed during the exit meeting, and any necessary adjustments are made to the audit report.
- XII. **Approval & Signing:**
After incorporating the necessary comments, the final audit report is submitted to the RAA for approval. Once approved, the report is signed by both the client and the auditors, then forwarded to the RAA for the preparation of the transmittal letter. The RAA then dispatches the report to the relevant offices.

Fee Structure

At RFPL, audit fees are determined based on the review of the client's draft financial statements. The nature of the business, anticipated complexities, and time required based on similar past engagements are considered when estimating the audit time and audit fee. There is no set minimum fee structure.
