1. INTRODUCTION

The development of an **Audit Universe** is a foundational element in the Royal Audit Authority's approach to risk-based and strategic audit planning. It serves as a comprehensive inventory of all potential auditable entities and areas under the purview of the RAA, forming the basis for the Annual Audit Schedule (AAS). This exercise is instrumental in promoting good governance by ensuring systematic, prioritised, and transparent audit coverage across the public sector.

Given the constraints on financial and human resources, it is not feasible to audit all agencies in a single fiscal year. The categorisation of agencies, therefore, enables the RAA to rationalise and optimise its audit efforts based on risk, materiality, and the strategic importance of entities. This approach ensures that resources are directed where they can have the highest impact. The classification system also provides the flexibility to respond to emerging priorities and institutional changes.

While the existing classification structure, from A1 to C3, has offered a consistent and practical framework for audit planning, the evolving landscape of public service delivery has underscored the need for continuous refinement of the underlying parameters to ensure the framework remains responsive, relevant, and effective.

In response to deliberations during the recent AAGs' Meet, the RAA has reaffirmed the existing classification structure while applying rationalised adjustments to man-day allocations, ensuring a more proportionate distribution of audit resources. The revised Audit Universe for FY 2025–26 reflects these changes, incorporating percentage-based increases or decreases, drawing insights from previous years' experiences. This ensures alignment between audit effort and the relative size, complexity, and significance of each agency, thereby enhancing the efficiency, coverage, and impact of the RAA's audit mandate.

1.1. Purpose

The Audit Universe serves as a strategic tool that enables the RAA to systematically plan, prioritise, and execute audits in a manner that ensures accountability, transparency, and the effective use of public resources. It forms the foundation for risk-based audit planning, allowing the RAA to adopt a proactive and structured approach in identifying and assessing potential audit areas across all levels of government and the public sector.

1.1.1 Comprehensive Audit Coverage

The Audit Universe provides a complete inventory of all auditable entities, functions, programs, and systems. This ensures that no significant area of public interest is overlooked and helps maintain consistency in audit scope over time.

1.1.2 Informed Risk-Based Planning

By mapping entities based on size, risk, complexity, and strategic relevance, the Audit Universe enables the RAA to allocate its limited resources efficiently. High-risk and high-impact areas can be prioritised, while ensuring a reasonable audit cycle for lower-risk entities.

1.1.3 Promoting Accountability and Good Governance

A structured Audit Universe supports the RAA's constitutional mandate to promote good governance by holding public institutions accountable. It enables audits that are responsive to changes in the governance landscape, including financial reforms, policy shifts, and emerging risks.

1.1.4 Resource Rationalisation and Efficiency

Through classification and prioritisation, the Audit Universe informs the allocation of man-days and audit teams. This ensures that audit effort is commensurate with the complexity and scale of operations of each agency, thereby improving audit efficiency and effectiveness.

1.1.5 Adaptability to Institutional Changes

The Audit Universe is dynamic and designed to evolve with changing public sector structures. It accommodates new institutions, mergers, restructuring, and policy changes, ensuring that the RAA's audit planning remains relevant and forward-looking.

1.1.6 Enhancing Transparency and Strategic Oversight

A transparent audit planning process, grounded in a well-defined Audit Universe, reinforces the credibility of the RAA's oversight function. It provides a basis for justifying audit choices and frequency to stakeholders, including Parliament and the public.

1.2. Scope

The RAA's Audit Universe encompasses a wide range of entities and audit areas, including but not limited to:

A. Institutional

- i. Accounts of the budgetary bodies, including the agency of the Government;
- ii. Foreign-assisted, donor-assisted or special projects of the Royal Government;
- iii. Embassies, consulates, and other foreign-based government agencies;
- iv. Zhung Dratshang, Rabdeys, and all related institutions;
- v. Defence and Security Services;
- vi. Constitutional bodies, Commissions, and any other government agencies;
- vii. Autonomous state colleges, universities and all autonomous bodies of the Royal Government;
- viii. Registered Political parties;
- ix. All state enterprises in which the government has a stake, financial institutions, including the Central and other Banks and their subsidiaries established under the laws of Bhutan in which the Government has an ownership interest;
- x. All entities, including non-governmental organisations, foundations, charities and civil societies fully or partly funded by the Government; whose loans are approved or guaranteed by the Government; and those receiving funds, grants and subsidies directly or through the government and collections and contributions from people and funds raised through lottery;
- xi. Any entity, whether private or public, engaged in extracting, processing, trading, and mining of natural resources of the State;
- xii. Any other public interest entity, if considered necessary by the Auditor General;
- xiii. Accounts and operations of international agencies based in Bhutan, if required under specific arrangements; and
- xiv. Any entity or activities upon command of His Majesty The Druk Gyalpo.

B. Functional

- i. Financial Management and Accounting Systems
- ii. Procurement and Contract Management
- iii. Revenue Generation and Collection
- iv. Human Resource and Payroll Systems
- v. Performance and Service Delivery Outcomes
- vi. Information Systems and Cybersecurity Controls
- vii. Environmental and Sustainability-related Expenditures
- viii. Public Asset Management
- ix. Grants, Subsidies, and Transfers

2. AGENCY CATEGORY AND PRIORITY

To ensure a structured and risk-responsive approach to audit planning, the RAA classifies all auditable entities into defined categories based on their institutional size, operational complexity, financial exposure, and public significance. This classification serves as a critical input to the AAS and directly informs the allocation of audit resources, including man-days and audit frequency.

2.1. Category

Audit agencies are classified into three major categories, A, B, and C, based on the relative size and complexity of their operations and functions. While this classification does not rely on quantitative financial metrics such as budget, expenditure, or turnover, it is grounded in field observations and informed professional judgment. The categories are defined as follows:

2.2. Priority

To guide the frequency of audits within the audit universe, agencies are assigned one of two audit priorities, Priority 1 (P1) or Priority 2 (P2). This prioritisation is informed by a combination of statutory obligations, professional judgment, and contextual considerations, and is intended to support a risk-responsive and resource-effective audit approach. The assignment of audit priorities is based on the following overarching parameters:


- Regulatory or legal requirements, including stipulations outlined in relevant Acts, agreements, or other binding instruments;
- Perceived risk, derived from RAA's experience and findings from prior audit engagements; and
- Other considerations, as deemed relevant and appropriate by the members of the AAGs' Meet, in line with institutional priorities and emerging issues.

Priority	Indicative Audit Frequency
P1	Agencies under this category shall be audited annually
P2	Agencies under this category shall be audited at least once within two years

2.3. Audit category and priority for the FY 2025-26

To ensure consistency and uniformity in assigning categories and priority to agencies with similar mandates and operations, the Divisions/OAAGs agreed on a common modality, which was adopted as part of the Audit Universe for FY 2024–2025. While agencies may share comparable functions, differences in size and operational scale warrant and continue to justify distinct classifications. Both the assigned category and priority remain dynamic and are subject to annual review, based on changes in budget, expenditure, operational nature and complexity, and audit experience. During the recent AAG's Meet, the previously adopted modality was reviewed and reaffirmed, with consensus to continue its application for the current audit cycle as detailed in *Annexure I*.

To facilitate audit scheduling and the allocation of available audit resources, particularly the deployment of auditors for specific agencies, we have further categorised agencies based on the defined man-days required to complete their audits. The largest agency (A1) is allocated a maximum of 90 man-days, while the smallest agency (C3) is allocated a maximum of 10 man-days. The table below outlines the rationalised man-days for Dzongkhags, Financial Institutions & Corporations, Thromdes, the Royal Bhutan Army, Hydropower Projects, and the CARLEP Project. To ensure proportionate allocation, maximum man-days have been derived for these agencies as follows:

2.4. Divisional/Regional Jurisdiction

Under the jurisdiction of RAA, there are 444 agencies. The summary of Agencies under each Division and OAAGs is as indicated below:

In addition to the Division/OAAG's jurisdiction, there are 24 centralised agencies, 46 Financial Institutions and Corporations, and 211 NGOs, CSOs, and ROs. Thus, the overall audit universe under the jurisdiction of RAA is 727 agencies.

The RAA broadly carries out three audit categories - Financial, Performance, and Compliance Audits. While the performance audits may or may not entail agency-specific auditing, the financial and compliance audits are generally agency-specific or related to the financial accounts and operations of audited agencies. The financial audits include audits of Letter of Credit (LC) Accounts, Project Letter of Credit (PLC) Accounts, Current Deposit (CD) Accounts, Revolving Accounts, etc. For the convenience of categorisation of types of accounts to be audited, all other accounts of non-budgetary agencies such as CSOs, NGOs, ROs, etc., are grouped as 'Others' Accounts. The compliance audits include audits of corporations and financial institutions whose financial accounts are audited by statutory auditors empanelled with the RAA. The RAA's audit in corporations and financial institutions involves only compliance and propriety issues.

The RAA is required to carry out 347 Financial Audits and 97 Compliance Audits. The Performance and Compliance Audit topics are given separately in the Performance Audit Strategic Plan 2020-2025. The audit of donor-funded projects will be audited and certified at the Project Management Unit level. The Audit of Ministries, Regional Offices, Royal Bhutan Police, Dzongkhags, Drungkhags, and Gewogs will be carried out as consolidated audits. Additionally, the audit of sports federations and associations will be carried out as one consolidated audit under the Bhutan Olympic Committee. The table below shows the agencies falling under the jurisdictions of Divisions/OAAGs by Audit Priority, Audit Category, and Audit Type. The detailed lists are given in *Annexure II*.

2.5. Preparation of Annual Audit Schedule

While preparing the AAS as per the assigned Priority (P), the Divisions/OAAGs will ensure to maintain or meet the minimum requirement as per the priority assigned to the agencies under their respective jurisdiction. A minimum number of agencies to be audited during the year by respective Divisions/OAAGs is calculated as below:

- a) 100% of agencies assigned with priority P1; and
- b) At least 50% of agencies assigned with priority P2.

This would ensure that Divisions/OAAGs can complete the audit of particular agencies as per the requirement, and there are no backlogs as far as the frequency of audits and the prescribed timeframe are concerned.

However, some of the Divisions/OAAGs may not be able to plan a minimum number of audits derived from the priority assigned due to a shortage of available man-days in comparison to the man-days required. Deferral of audits in such situations becomes inevitable. The Divisions/OAAGs are recommended to compare the available and required man-days as follows:

If the available man-days are more than the required man-days, the Division/OAAGs must ensure that fruitful engagement of available man-days is made by incorporating additional agencies for audit.

If the available man-days are not sufficient to complete the minimum number, the AAG may ensure that due diligence is exercised in the allocation of man-days in the AAS. Even after revisiting the allocation of man-days in the AAS, if available man-days are still not sufficient, then it shall form a basis for requisitioning additional manpower.

3. UPDATES, REVISIONS AND RE-CATEGORISATION

The Audit Universe is not a static repository, it must evolve in step with institutional, legal, and operational developments in the public sector. Regular updating and maintenance are essential to ensure its continued relevance, accuracy, and utility for effective audit planning.

The Policy and Planning Division (PPD) is responsible for updating the list of agencies annually, relying on information from respective Divisions/OAAGs and relevant authorities such as the Ministry of Finance. Simultaneously, Divisions and OAAGs are required to update their existing lists of agencies under their jurisdictions. The categorisations are also subject to annual review during the AAGs' Meet before the commencement of AAS preparation. To facilitate this, they must maintain up-to-date information for agency updates, re-categorisation, and re-prioritisation purposes.

3.1. Accountability and Oversight

The PPD, in collaboration with the auditing Divisions and OAAGs, ensures that the Audit Universe is reviewed, validated, and endorsed annually before finalising the Annual Audit Schedule. This collaborative model strengthens ownership and aligns planning with field-level realities.
